TSCA Import Compliance Checklist

The U.S. Environmental Protection Agency (EPA), in consultation with the U.S. Bureau of Customs and Border Protection (CBP), has developed a new April 2008 "TSCA Section 13 Import Compliance Checklist." This new guidance document provides a roadmap to help chemical importers determine how to certify their chemical imports for compliance with the import requirements under section 13 of the Toxic Substances Control Act (TSCA) and 19 CFR §§ 12.118-12.127.

John S. James In The Community Export Space Constraints

In the last edition of the J-Report we mentioned the explosion of the Imperial Sugar Refinery on February 8th. Though the stories of the victims escape the attention of the front pages, their needs are just as urgent as those days following the tragedy.

John S. James Co. answered the call of the Shepard Community Blood Center. Our company provided transportation and time off for those employees who wished to give blood. These patients will be facing multiple surgeries in the months ahead and as a result will require tremendous amounts of donated blood and blood products.

Why should I give blood?

- Every 2 seconds someone needs a blood transfusion.
- 37% of the population is eligible to donate, only 10% do on an annual basis
- About 1 in 7 people entering a hospital need blood.
- One donation can save up to three local lives, since blood can be separated into the compon-

- ents red blood cells, platelets, and plasma.
- Studies show that donating blood just 3 times a year may: lower your blood pressure, reduce your risk of a heart attack by 50%, lower your chances of developing colon, lung, bladder and esophageal cancers by 40%.

That is because excess iron actually promotes the growth of cancer in the body by producing free radicals and feeding cancer cells. Blood donation is the only practical and effective method for the removal of excess iron. For men with moderate excess iron accumulation, periodic blood donation may help to reduce the iron the body stores to a more healthy level. Anyone who is in good health is at least 16 years old with parental consent - or 17 years or older - and weighs at least 110 pounds may donate blood every 56 days.

Vessel space on outbound vessels is getting harder to find. Hapag Lloyd has announced the following. Will other carriers follow?

Effective May 5th bookings will only be taken **six weeks prior** to vessel sailing

We are also implementing a No Show policy that will take effect May 15th. If a booking does not show up for its scheduled cut-off the booking will be cancelled and not be rolled.

If you should choose to roll the booking before the cut-off date the booking will be rolled to the first available vessel with space. Rolling the booking before the cut-off date does not ensure your cargo will be placed on the following vessel. However our customer service and allocations teams will do their best to accommodate your business needs.

Truckload Shipments to Mexico

Are you shipping to Mexico????

Truckload shipments to Mexico have the potential to be quite problematic. When the truck arrives at the border the cargo must be offloaded and placed onto a Mexican Inland carrier in order to proceed to destination.



The offload, reload and re-securing process causes delays, handling charges and extra liabilities. If the cargo is damaged in the process it could create an insurance nightmare trying to determine which party was negligent in the handling of your goods.
